

# Statement Dr. Reiner Fuellmich Nov 30, 2024

Dear friends,

On November the 5th, a majority of the American people kicked in the door to justice. And that's despite all the lies and all the attempts at manipulating them. Despite the chaos we're currently seeing, anything is possible now, I believe. So I will take this opportunity to give you an update of my status, of my status quo. And if you're interested, I'll give you my view of the events unfolding now after November the 5th. Thirdly, I want to tell you about a very strange, sudden and unexpected event that happened here last week in this prison. And finally, there's a very positive event, which I think will be motivating for every one of us in Romania. I'll tell you about that thing, that event at the end of my statement.

So I'm still standing, despite their attempts at driving me into insanity with their measures of what is called white torture. I have not caved in yet, and I do not intend to cave in. Now, when I tally up what they've been doing to me, don't get me wrong, I'm not sitting here under the table and whining. I'm doing this in order to remind myself of what's been happening over the last five and a half months. And I'm doing this also for my parents and my grandmother. I don't want to forget any of this, because I'm not going to forgive any of this either.

So I've been held in solitary confinement for the last five and a half months. Transportation between the prison and the court is still done with me being chained and shackled and guarded by heavily armed prison guards and police. And I'm still constantly being reminded by these guards, even though many of them apologize in the meantime, because they sympathize with me, that if I refuse to wear a bulletproof vest, a straight bullet may hit and kill me. They did not let me see my dying mother. And they refused to let me join my family for the burial, the sea burial of my mother. The two fellow inmates whom I gave legal advice on how to make the state of Lower Saxony and those individuals who are directly responsible for beating them black and blue, one of them actually got his skull bashed in, those two guys who I gave legal advice to on how to get damages from the state of Lower Saxony were transferred to another prison, so they wouldn't be able to talk to me anymore. I'm not just saying this, we have this in writing, because the woman who is in charge of this prison or the deputy director of this prison wrote this down. She said that they transferred these two guys to another prison so that we wouldn't be able to talk to each other anymore. Of course, in reality, what they're trying to do is cover their tracks, cover up what they did, but it's too late. They cannot make this undone. I am still being kept in a cell that never really gets warm in the wintertime, because it's located right at the edge of the prison building, albeit with a perfect view of the prison wall, some 30 or 40 yards away from me, and a razor wire on top of it.

There is some positive news, too. The poor guy, the psychiatric patient whom they had put into the cell adjacent to mine, has finally been taken to a psychiatric hospital. However, in exchange, there are now two other people who are really serious cases of heavily traumatized people. One of them, he suffered serious, serious sexual child abuse. The other is heavily traumatized, a Syrian who as a child was exposed to a lot of violence, war and violence in Syria. Both of them are nice people, but they're totally insane. Every once in a while, they destroy all the furniture, the bed, the chair, the table, the closet, even the sink, because they're totally lost, and they don't belong here either. Again, I'm still standing.

Here's the good things. Apart from the fact that the man who was waiting to get real treatment in that cell adjacent to mine, apart from the fact that he is finally, at least that's what they told us, finally getting that help, we have also been successful in getting permission for me to work out again. Once a day for 30 or 45 minutes, they take me to one of the fitness rooms on the floors above this special security ward. They lock me in there, and then I can work out, do pull-ups and push-ups and all those things, which I cannot do because this prison cell is way too small to even move around. Stretching, you can't do in there. I can go run in that prison courtyard because now I have my running gear. I'm, in fact, almost back to normal, physically at least.

The upshot is, even though it is obvious that all of the above-mentioned measures of what is called white torture are designed to drive me insane, or anyone who is subjected to such measures drive them insane, so that ultimately I'll either commit suicide or go so crazy that I attack the monsters. Neither will happen. This is really thanks to you. Thanks to your massive support, my friends. Thanks to this ever-stronger sense of being somehow connected with all of you, which is hard for me to grasp because I'm a rational thinking attorney, but for some reason, all of this is actually coming through to me. This really does feel as though there is some kind of energetic connection. I don't know how to explain it, but that's the way it is, or else I wouldn't be standing. But, of course, it's also thanks to my wife that I'm staying calm and focused. So, I will not back down. I won't back down, just like Tom Petty sang.

We do realize now that this has always been a two-tiered attack. The fake legal case has always been nothing but a cover for the real goal to take me down because of my plandemic activities, because of the fact that I did all these interviews, because I wanted to know what I suppose many of you also wanted to know. I wanted to know what's really going on. And I knew, with my background of not just tort law, but medical malpractice law, I knew, of course, that something wasn't right. So, that's why they wanted to take me down, and they're using this show trial in order to do it. And since they've always known that before long, this fake legal case would unravel as it did on May the 3rd, when they had to invent totally new and totally stupid charges, they were always using this other level, and that is the white torture level. However, they will not succeed on this other level either. And that has to do, of course, with your support, but it also has to do with the platform on which I'm standing, the basis which, I suppose, gives me the strength to keep doing what I'm supposed to do. It has to do with my grandmother, Emma, but it also has to do with my parents.

So, let me tell you a little bit about them. I hope this is not going to be too intimate, but I think it's important so that you understand that I really mean it when I say I do not crack under pressure. I already told you that my grandmother, Emma, made sure that I understood about human dignity, because that's what it was when she told me that I can do anything I want, but that I must never let myself go, neither physically, wear clean clothes and keep in shape, nor morally, keep your promises. But I believe it's not just my grandmother, Emma, it's also my parents that have something to do with the fact that I will not break, I will not crack under pressure. Because both my father and my mother were children when World War II ended. My father was 13, my mother was 11. They, like my wife's parents, were badly traumatized, just like everyone else in that war, including the soldiers, by what they had seen in the war as children. But, of course, back then nobody knew about traumatization, nobody understood about what it had done to the people. Now we know this. My father was haunted by the fact that he and his friends, when he was 11, weren't able to help the U.S. or British pilot who crash-landed his fighter plane after it had been shot down by the Germans, crash-landed it in the street where my father lived. His father, at that point, was a prisoner at war in Russia, so he was basically in charge of the family. But when he and his friends ran to the site of the

crash, hoping to be able to pull the pilot out of his cockpit and help him, he was dead, with half his head gone. So, my father always wanted to know, he knew there's somebody responsible for this, and he knew this didn't happen out of nowhere. Somebody was responsible. He knew that, and that's why he wanted to know who it was. That's why he kept reading everything he could on the war, including, by the way, Norman Mailer's "The Naked and the Dead", and that's why he watched all these old newsreels over and over and over again. That's ultimately why he became a police officer, and that's also why he kept explaining to my sister and me that the statue of Roland the Knight in the center of Bremen's old marketplace symbolizes freedom and justice. He has a sword drawn and a shield in the other hand, and there's a crippled person beneath his feet whom he's protecting, and that's what he kept telling me and my sister. We should never bow to anyone, to no authority, and never accept any medals from anyone.

My mother, who was the love of his life and vice versa, her family came from Bremen, and their home was destroyed when Bremen was basically obliterated during the war, and she and her four siblings and her mother and father had to move to my great-grandmother's house out in the country. Every day for many months, she had to walk for miles and miles to get to a train station where she would catch a train that would take her to the nearest town with the school. So she did that for many months. I think she did it for a year and a half, and she had no shoes.

Why am I telling you this? I think I want you to get an idea why I really will not crack under pressure. Rather, I'm staying focused on what needs to be done. I know that I'm still very good at my job as a tort lawyer, recovering damages for my clients, and I'm determined to finish the job of getting the truth out about the plandemic and getting damages from the monsters for all those who suffered physical and/or economic damage from the measures, the lockdowns, the shots, etc., etc.

Now, this brings me to November the 5th. On that day, a majority of the American people kicked the door in for all of us to walk through. Sure, many voted for Trump because they think that he'll bring the economy back on track, and I think he will. But still, they all either ignored the constant attacks on him in the mainstream media and by politicians, or they actually saw through this web of lies and propaganda and manipulations. Either way, they were definitely not impressed by all those overtly stupid attempts at framing him as a Nazi.

On the same day, as you probably know, the scarily incompetent German coalition government finally collapsed, leaving behind a huge economic mess and no way out of this. In fact, the former secretary of finance, he was fired by our chancellor, openly said on television that he thinks that the government is deliberately destroying the economy. He doesn't have any idea how correct he really was. Most people, however, agree with him. The real problem, however, is that just like in England, where now a robot is ruling and ruining the economy and the farmers, driving the economy into the ground, and in France, which has ground to an eerie halt altogether, there's not a single politician, at least in Germany not, who has integrity, authenticity, and at least some semblance of charisma. The majority of the population is either stupid, as Pastor Dietrich Bonhoeffer famously stated shortly before he was murdered in a Nazi prison, or cowards, as philosopher Immanuel Kant announced in the mid-18th century, trying to get the people to finally think for themselves and not just do and think as they were told.

However, it only takes a few good men and women to change the world for the better. And we are those few good men and women. We are the cavalry. We have everything it takes. The others have nothing. If Donald Trump and RFK Jr. play their cards right, and I think they

will, they will drain the swamp by exposing the criminals who committed all those crimes against humanity and who are hiding in those muddy waters of that swamp. All those corrupt politicians, puppets, whose strings are being pulled by evil global corporations and global organizations such as the EU, NATO, the United Nations, and so many others. I'm sure that Donald Trump and Robert F. Kennedy Jr. understand this.

Now, I still continue to believe that exposing the corona-plandemic for what it is, not a pandemic, but a plandemic, will open everyone's eyes. It'll make it easier for the people to understand and take a closer look, a second look at all those other things that some people have always known are not quite right. You know, 9/11, the climate hoax, which is incredibly stupid, fighting CO2, paying 1.3 trillion dollars as they demand it to, what, to destroy CO2? How stupid can it get?

However, there is this other big issue, and that is very urgent at this point in time, and that is the matter of Gaza. Gaza is difficult, and Gaza should be dealt with immediately. In the meantime, I think the number of people killed in Gaza has surpassed 44,000, which amounts, and that's in 13 months, and that amounts to 125 people killed every single day, most of them women and children. I told you that I've been following this very closely over the last 13 months by comparing the journalism that I could see on TRT World on the one hand, who's also a mainstream medium, but it's not quite as bad as the others, with the British, the French, and worst of all, the German mainstream media. Because TRT are the only ones who have actual reporters on the ground. All the others, when they do get a chance to have their reporters on the ground, are always embedded with the Israeli army. When I compared what those two sides, TRT World on the one hand, and all the others on the other hand, were showing us every day about the absolutely horrific situation on the ground, when I compared those two deliveries, the only conclusion I can draw as a lawyer is TRT is exposing the lies of the other mainstream media, the narrative that everything is justified that happens there because Israel has a right to defend itself. That's a blatant lie. These people, the people who are being killed, most of them are women and children. And if you have a chance, take a look and see for yourself, take a look and a listen to TRT's reporting on the Gaza massacres. You'll find their extraordinary interviews on YouTube too, their interviews with the American combat surgeon, Adam Hammami, the former Israeli ambassador to South Africa, Ilan Baruch, interviews with Roger Waters, and with a former member of the US Foreign Service who left in disgust. Her name is Hala Rharrit, but also an interview with the president of the US Middle East Project, Daniel Levy, and the investigative journalists Max Blumenthal and Aaron Maté, or the presidential candidate for the US Green Party, Jill Stein. She too is Jewish, and she says this is not about Arabs and Jews. This is about humans. It's about humanity. And she's right, of course.

And for once, I was proud to not yet have given up my German citizenship when I listened to an interview with the former assistant general secretary of the United Nations, Hans von Sponeck. Very, very, very interesting and good interviews. They give you a clear picture of what's really going on there. As you can see, there are more than just a few good men and women, even in corrupt institutions like the United Nations.

On November the 21st, finally, when many people had already been musing about the old true saying justice delayed is justice denied, the ICC, the International Criminal Court, finally issued arrest warrants for Netanyahu and his former defense secretary, Galant. This is a very important signal as it shows that they're not immune and they will not escape justice. Even more important, it signals to all of those who participated and continue to participate in that genocide that they too will not escape. Who is that? Well, for example, the sniper who killed the 26-year-old Turkish-American woman who was demonstrating peacefully with a

small group of peaceful people and got a bullet to the head that killed her. The men and women who tied injured Palestinians to the hoods of their armored vehicles, using them as human shields. The pilots who bombed tent cities and the tank commanders who shelled hospitals and schools and chased, in one instance, a female journalist through the streets. And all those who deliberately starved the people in Gaza by withholding food and water.

No one will get away. And that is because we, the people, are here watching this and we're coming. Justice is coming. Even though I suppose that those who are pulling the strings and also those who committed the crimes, most of them are psychopaths or sociopaths and have absolutely no empathy. So, they will not be haunted by those images of the children whose arms and/or legs had to be amputated. But what they will understand is that they will not get away with the feeble excuse that they followed orders. That has not been a valid excuse, let alone justification, for such crimes since Nuremberg 1.0. And it will not be a valid excuse nor justification for any of the other crimes against humanity that have been committed, least of all for those committed under the guise of the plandemic.

And that brings me to my third strange experience, which I had last week. Twice a week, I usually go get a dental checkup. I was there in, I think, January or February. I met this dentist who has his private practice right outside the prison. He comes here twice a week. He asked me if I was the guy who was getting all this support from all those people. I said, "Yep, I'm here because of corona." He said, "Yeah, well, I don't know if everything was done correctly. I think they overdid it." I said, "Well, did you get your shots?" He said, "Yes." I said, "Well, I can put you in touch with real doctors who will help you get that toxic brew out of your body." He said, "Ah, it can't be that bad." Now, that's strange. On the other hand, maybe it's not strange because many people who could and should see the danger of these shots, now that finally all the numbers are coming out, we know that at least 20 million people died because of the shots. And we know that, what, 2.4 very serious adverse events happened because of the shots. But most people don't want to know about it. This guy didn't want to know about it either. He said, "Oh, it can't be that bad." Now, that is strange but understandable. So, last week, I was there once more for my second checkup. And they made a mistake because they put me into a holding cell, not by myself, isolated from everyone else, but there was one other inmate in there. He was waiting, a drug addict, poor devil, who was waiting to get some serious dental work done. Finally, when he was called into the dentist's office, I could see everything from my cell because there's a window in that door. I could see all the way down the hallway. I could see him disappear through the door to the dentist's office. It's only 20 feet from me. And then, some, I don't know, five minutes or so later, I saw the dentist, who's a physically fit guy in his mid-50s or late 50s maybe. And he opened the door and he came staggering out, staggering and stumbling, almost fell. Then he turned around and saw me. Since I have this red-green weakness, I wouldn't have been able to see if he's red or green, but I did see that he was white. He was pale. Looked at me because he recognized me. Then he turned around again, collapsed, got up again, and then disappeared through another door. Now, a minute later, the dental assistant, a young woman, totally confused, appeared in the hallway. Then the patient appeared. Then three guards took him back to the holding cell where I was waiting for him. And he told me that he was so sorry for that guy because he was such a good guy and he was hoping he would get better soon. He had already gotten his shot, I suppose it's Novocaine or something, some anesthetic. And he said, "It's not important that he operates on me now, but I just hope he's going to get better." I said, "Well, we'll see." The guards who then took me and the other patient back to our cells told me that the dentist had to be whisked away by an emergency ambulance and that they were told that for many, many weeks this guy wouldn't be able to come back. I don't know if this is correct. We'll see. This morning, I was told that he's already back on duty. I'll see on Thursday, and then I'll let you know if this is another case of sudden and unexpected. I hope

not because he's a nice guy, but I hope he'll come to his senses and make sure that the stuff gets out of his body.

Now, the strange thing is that many people really do not seem to want to know what's really going on. For example, the woman who is in charge of pretrial detention here, she speaks to me every three weeks or so because she wants to know how far I have gotten with all those criminal complaints, and she wants to know if I want to continue with them. She's the one who said, "No, it's sometimes better not to know everything. It's healthier for you." I said, "No, it is not healthier for you." Now, I have a case in point. Next time I see her, I'm going to talk to her about that guy. It's normal because you have probably seen Professor Bhakdi explaining about this phenomenon of some people who received the shots had personality changes. I did this interview with probably the most famous American psychiatrist, my friend, Dr. Peter Breggin, and with Naomi Wolf. Naomi spoke about how she had gone to a party in New York where many people who came to that party had gotten the shots, and everything seemed normal on the outside, but for some strange reason, some of them appeared to be changed like robots. Peter Breggin said, he can confirm what Professor Bhakdi says, because to him, some of the symptoms that some of these people seem to have suffered as far as the personality changes are concerned, to him, this sounded a lot like all those poor people who were subjected to lobotomy, which is when they punched holes into the frontal lobe of the brain, calling this a medical treatment, which, of course, it wasn't. He's the guy who stopped it.

In summary, a majority of the American people have kicked in the door through which we can see the sunlight, which is still the best of disinfectants. It's streaming in, lighting up the dark mess so that eventually, we will be able to see everything.

One more thing, though. Remember the interview I did with the former high-ranking UN executive who told us that the UN had turned into an utterly corrupt institution, just like the Club of Rome, and that it had literally been taken over by the World Economic Forum by 2019? That interview, our friend David Sorensen from Stop World Control made that interview really famous. Millions and millions of people watched it. Well, back then, I did that interview in December of 2021. My wife and I were in Bucharest, in Romania then. Back then, he was preparing to run for the presidency in his country. I guess you could say that I did play a part in these preparations because we introduced the Romanian version of Robert F. Kennedy's book on Fauci, "The Real Anthony Fauci", to the Romanian people. You know what? I just saw on television that he is about to win the presidential election in Romania. I hope he's going to make it because I think this is really, really good news.

At any rate, let's not forget that we, the real humans, the real people, we are the cavalry. Of course, we're hoping for the best. I'm hoping that Calin Georgescu, he's the guy who's about to win the presidential elections in Romania, but also that Donald Trump and Robert F. Kennedy Jr., who to me are the center of gravity in the incoming American administration, that they're going to do the right thing. I'm absolutely convinced that they're going to do their best. It's always us, the people, who are ultimately going to be the cavalry. Whatever you think, there's chaos right now, but I think we're moving into a better time. It's already begun, even though I can't really put my finger on it, but there's this old song by a band called Thunderclap Newman, and it's called "Something in the Air". That's what I think everyone can feel now. Don't confuse this song with Phil Collins' song, which is called "Something in the Air Tonight". That's the other song. Thunderclap Newman, "Something in the Air", and I think that's the truth. I'll see you all soon.
